## **PUBLIC COMMENT**

Caroline Dueppengiesser - Holiday Lights - Ms. Dueppengiesser reported to the board on the upcoming Holiday DeLights Festival on December 3, 2011. The main festival will be held in the Festival Plaza on Main Street. They will go around and speak with all of the businesses downtown. The festival will start at 5 pm with the tree lighting. They are requesting that Main Street be closed. Ms. Dueppengiesser will meet with Terry to discuss this request.

**Engineering approved for filter beds 1 & 2** - Motion by Trustee Laraby, seconded by Trustee Davis, to approve Clark Patterson to prepare the engineering, up to \$2,000, for the conversion of filter beds 1 & 2 to GAC (granular activated carbon) for approval by the Wyo. Co. Health Department. Motion carried with all voting aye.

Water & Sewer Report approved - Motion by Trustee Laraby, seconded by Trustee Davis, to accept the Water & Sewer Report as presented. Motion carried with all voting aye.

Engineering for conversion from liquid to gas chlorine - Chief Operator Hinz requested that the village switch from liquid chlorine to gas as gas chlorine is cheaper and safer to use. He explained that the gas chlorine is a constant feed, where liquid chlorine looses it strength with higher temperature. Trustee Barth requested a summary of the costs of liquid chlorine versus gas chlorine. Estimated costs for engineering this conversion is no more than \$6,000. The Wyo. Co. Health Department must okay the engineers plan before any conversion.
