VILLAGE SPECIAL BOARD MEETING**

MAY 10, 2013

The Special Board Meeting of the Village of Perry was held at the Village Hall 46 North Main Street Perry New York at 1:00 p.m. on the 10th day of May 2013.

Mayor Hauser called the Meeting to order at 1:00 PM.

Owen Buehler appointed Seasonal Laborer - Mayor Hauser appointed Owen Buehler as a seasonal laborer at a rate of \$10 per hour and a start date of May 13, 2013. Motion by Trustee Jacobs, seconded by Trustee Billings to, approve the Mayor's appointment as presented. Motion carried with all voting aye.

Community Service for Don O'Geen tournament approved – Motion by Trustee Billings, seconded by Trustee Jacobs, to authorize five (5) community service people under the direction of Don O'Geen for his tournament only on May 31, June 1, and June 2. Motion carried with all voting aye.

Splash Pad Project

Mayor Hauser introduced Lynn Mason and Ben Frasier from Parkitects. They explained that they have a working partnership with equipment manufacturers. Mr. Frasier explained how spray parks work and difference between the two types. Different types of equipment and activators were explained (as shown in the equipment catalog from Water Odyssey.) Ms. Parker said that her small kids do not like water poured from above. Ms. Mason showed the group a sample layout of the splash pad project and surrounding benches, trash receptacles and landscape structures. She inquired if a swing set could be relocated and they feel the splash pad is right on top of the playground. Mr. Frasier recommended having separate areas for the different age groups with the design to flow the areas into one another. Trustee Jacobs suggested having individual sponsors for different pieces of equipment. Mr. Frasier said that he hopes to have design plans by the end of June. Mayor Hauser asked for a couple of site plan proposals.

Mayor Hauser announced that there will be another special board meeting on the splash pad project on Friday, May 31, 2013 at 1:00 pm.

Motion to adjourn meeting at 2:15 p.m. was offered by Trustee Jacobs, second by Trustee Billings and carried with all voting aye.
