Mayor Hauser called the Meeting to order and led in the pledge to the flag.

MINUTES

SEPTEMBER 17, 2018 REGULAR MEETING MINUTES APPROVED - Motion by Trustee Jacobs, second by Trustee Billings the minutes of the September 17, 2018 Regular Board Meeting were approved as presented. Motion carried with all voting aye.

SEPTEMBER 27, 2018 SPECIAL MEETING MINUTES APPROVED - Motion by Trustee Jacobs, second by Trustee Billings the minutes of the September 27, 2018 Special Board Meeting were approved as presented. Motion carried with all voting aye.

PUBLIC COMMENT

Dorothy Sealy thanked the board, DPW and office staff for the work done in Birchwood Acres. It was a great team effort. She said it renewed their spirit in how government can make a difference. Mayor Hauser thanked the residents for their patience and positive attitudes during the entire project.

PRESENTATIONS

TAMMY KELSEY – HOLIDAY DELIGHTS & “TRUNK OR TREAT”

Ms. Kelsey advised the board that the “Trunk or Treat” event will be a fund raiser for a local family that will be undergoing a kidney transplant on Halloween. There will also be a basket raffle with children trick or treating from vehicle trunks. Ms. Kelsey spoke on the Holiday DeLights Festival. The festival plaza has been reserved with letters going out next week to the businesses. The date of the festival is Saturday, December 1, 2018.

PART TIME OFFICER APPOINTED

Jordan McGinnis appointed part time police officer – Mayor Hauser appointed Jordan McGinnis as a part time police officer per the CSEA contract. Motion by Trustee Billings, seconded by Trustee Draper, to approve the Mayor’s appointment. Motion carried with all voting aye.

TENNIS COURT MAINTENANCE DISCONTINUED

The four main tennis courts foundation has failed and will have to be removed. Mayor Hauser reported that tennis has a bright future in Perry and the Perry Central School is looking to have a tennis facility that will fulfill their requirements. The PCS has asked the Village provide notice so they can work this project into their Capital Budget.

Discontinue Tennis Court maintenance letter approved – Motion by Trustee Draper, seconded by Trustee Jacobs, to approve the Discontinue Tennis Court Maintenance letter and authorize the Mayor to sign. Motion carried with all voting aye.

CONTRACT WITH SWBR FOR DESIGN SERVICES FOR THE PUBLIC BEACH FACILITIES

Contract authorized for signature – Motion by Trustee Billings, seconded by Trustee Jacobs, to approve and authorize the Mayor to sign the contract with SWBR for the design services for the Public Beach Facilities. Motion carried with all voting aye.

LAKE ST PARKING

Administrator Jensen said the parking zone will be adjusted on Lake Street to reflect that only 200’ of parking space will be allowed.

RESOLUTION

AUTHORIZING THE VILLAGE BOARD OF THE VILLAGE OF PERRY TO HOLD A PUBLIC HEARING ON A PROPOSED LOCAL LAW

WHEREAS, the Village Board is considering adopting a Local Law to amend the Village Code of the Village of Perry, specifically Section 405-18: Parking Prohibited At All Times and Section 405-24: Time Limit Parking; and

WHEREAS, the Village Board of the Village of Perry finds it in the best interest of the Village of Perry to hold a public hearing on the adoption of said Local Law; and

NOW ON MOTION OF Trustee Draper which has been duly seconded by Trustee Billings, be it

RESOLVED, by the Village Board of the Perry will hold a public hearing on the proposed adoption of said local law on the 5th day of November 2018 at 8:00 p.m., at which time all interested parties and citizens for or against the proposed law will be heard.

Trustee Billings said the Halloween parade will be at 7 pm with cider and donuts at the fire hall. The Perry Fire Department is getting involved in training for water rescue.

Mayor Hauser announced that the Village is looking to turn two (2) of the properties recently acquired over to developers. The Village will coordinate the demolition of 9-11 Travers Place.

UPWP GRANTS

LaBella grant application proposal approved – Motion by Trustee Jacobs, seconded by Trustee Billings, to approve the proposal from LaBella to prepare a UPWP grant that will focus on the N Center Street corridor and provide a \$7,500 match.
