Mayor Hauser called the meeting to order at 2:45 pm and led in the pledge to the flag.

PRESENTATIONS & BOARD ACTIONS

RESOLUTION AMENDING THE 2021-2022 VILLAGE OF PERRY BUDGET

Wyoming County Real Property Tax Services notified that the total taxable assessed value increased after the Board of Trustees adopted the 2021-2022 annual budget on April 19, 2021. An amendment is required in order to accurately produce the 2021 Village Tax Bills.

WHEREAS, the Village of Perry was notified that there was an increase in taxable valuation of \$20,000 due to a prior exemption; and

WHEREAS, the Village of Perry's total taxable assessed valuation will increase to \$137,523,080:

Town of Perry assessed value = \$28,469,347

Town of Castile assessed value = \$109,053,733; and

WHEREAS, the Village will collect an additional \$305.00 in taxes due to the increase valuation; and

WHEREAS, there is an additional \$583.49 in omitted taxes that will be collected in the 2021-2022 fiscal year; and

WHEREAS, the Village will collect a total additional amount of \$888.49; and

WHEREAS, the following budget amendment is recommended to allocate the additional revenue to sidewalk repairs:

INCREASE REVENUE: REAL PROPERTY TAXES (A1001) \$889.00

INCREASE EXPENSE: SIDEWALKS CONTRACTUAL (A5410.4) \$889.00

BE IT RESOLVED, that the Village of Perry Board of Trustees hereby amends the 2021-2022 budget to reflect the total assessed valuation of \$137,523,080 with a tax rate of \$15.253619; and

BE IT RESOLVED, that the Village of Perry Board of Trustees hereby approves the budget amendment to increase the total budget by \$889.00 for a total of \$2,708,484 in the general fund and a total budget of \$4,417,491.00 for the 2021-2022 fiscal year.

Trustee Billings made a motion to accept the resolution which was seconded by Trustee Draper and carried unanimously.

At 2:49 pm, Trustee Draper made a motion to close the meeting which was seconded by Trustee Billings and carried with all voting aye.
